1. University of London and LSE records confirm that Tsai Ing-wen was awarded a PhD in Law in 1984.

2. LSE is in possession of all relevant information pertaining to Dr. Tsai's degree. Dr. Tsai was originally registered as an MPhil student in September 1980. In her second year, upon the recommendation of her supervisor that her work was of doctorate standard, she was retroactively upgraded to PhD status. Dr. Tsai submitted her thesis "Unfair trade practices and safeguard actions", and successfully passed the viva examination in October 1983. She was later awarded a PhD in Law in 1984.
