- (1) This is alumna Tsai Ing-wen's personal matter. To avoid further accusation, such as 'she used her Presidential Office to do her personal matter', is it ok to delete the word 'office'? Suggest to revise sentence as follows:

“President Tsai Ing-wen recently provided the LSE Library with a facsimile copy of the thesis, *Unfair trade practices and safeguard actions*. This is available to view in the library's reading room.”

- (2) The 3rd paragraph seems contradictory to the 2nd. Is it ok to clarify by adding one word 'currently'? Suggest to revise sentence as follows:

“We have corresponded with the University of London

about the thesis and extensive checks have been made. **Currently**, neither Senate House nor IALS are able to locate a copy of the thesis.
